# Welcome to this meeting of the City Council of Roeland Park. Below are the Procedural Rules of Council

The City Council encourages citizen participation in local governance processes. To that end, and in compliance with the Kansas Open meetings Act (KSA 45-215), you are invited to participate in this meeting. The following rules have been established to facilitate the transaction of business during the meeting. Please take a moment to review these rules before the meeting begins.

- A. **Audience Decorum.** Members of the audience shall not engage in disorderly or boisterous conduct, including but not limited to; the utterance of loud, obnoxious, threatening, or abusive language; clapping; cheering; whistling; stomping; or any other acts that disrupt, impede, or otherwise render the orderly conduct of the City Council meeting unfeasible. Any member(s) of the audience engaging in such conduct shall, at the discretion of the Mayor (Chair) or a majority of the Council Members, be declared out of order and shall be subject to reprimand and/or removal from that meeting. Please turn all cellular telephones and other noise-making devices off or to "silent mode" before the meeting begins.
- B. **Public Comment Request to Speak Form.** The request form's purpose is to have a record for the City Clerk. Members of the public

may address the City Council during Public Comments and/or before consideration of any agenda item; however, no person shall address the Council without first being recognized by the Mayor (Chair). Any person wishing to speak, whether during Public Comments or on an agenda item, shall first complete a Public Comment or Request to Speak form and submit this form to the City Clerk before the Mayor (Chair) calls for Public Comments or calls the particular agenda item

- 1. Public Comment on Non-Agenda Items. The Agenda shall provide for public comment about matters that are within the jurisdiction of the City but are not specifically listed on the Agenda. A member of the public who wishes to speak under Public Comments must fill out a Public Comment Request to Speak form and submit it to the City Clerk before the Mayor (Chair) calls for Public Comments.
- 2. **Public Comment on Agenda Items.** Public comment will be accepted on Agenda items. A member of the public, who wishes to speak on an Agenda item, including items on the Consent Agenda, must fill out a Request to Speak form and submit it to the City Clerk before the Mayor (Chair) calls the Agenda item.
- C. **Purpose.** The purpose of addressing the City Council is to communicate formally with the Council regarding matters that relate to Council business or citizen concerns within the subject matter jurisdiction of the City Council. Persons addressing the City Council on an agenda item shall confine their remarks to the matter under consideration by the Council.
- D. **Speaker Decorum.** Each person addressing the City Council, shall do so in an orderly, respectful, dignified manner and shall not engage in conduct or language that disturbs, or otherwise impedes the orderly conduct of the Council meeting. Any person, who so disrupts the meeting shall, at the discretion of the Mayor (Chair) or a majority of the Council Members present, be subject to removal from that meeting.
- E. **Time Limit.** In the interest of fairness to other persons wishing to speak and to other individuals or groups having business before the City Council, each speaker shall limit comments to five minutes. If a large number of people wish to speak, this time may be shortened by the Mayor (Chair) so that the number of persons wishing to speak may be accommodated within the time available.
- F. **Speak Only Once.** Second opportunities for the public to speak on the same issue will not be permitted unless mandated by state or local law. No speaker will be allowed to yield part or all of his/her time to another,

and no speaker will be credited with time requested but not used by another.

- G. Addressing the Council. Comment and testimony are to be directed to the Mayor (Chair). Dialogue between and inquiries from citizens at the lectern and individual Council Members, members of staff, or the seated audience is not permitted. Council Members seeking to clarify testimony or gain additional information should direct their questions through the Mayor (Chair). Always speak from the microphone to ensure that all remarks are accurately and properly recorded. Only one speaker should be at the microphone at a time. Speakers are requested to state their full name, address and group affiliation, if any, before delivering any remarks.

(Roeland Park Council Meeting Called to Order at 6:00 p.m.)

#### Pledge of Allegiance

Mayor Poppa called the meeting to order and led everyone in the Pledge of Allegiance.

#### **Roll Call**

City Clerk Nielsen called the roll. All Governing Body members were present with CMBR Dickens attending virtually. Staff present were City Administrator Moody, City Attorney Felzien, Assistant City Administrator/Finance Director Jones-Lacy, Police Chief Morris, Public Works Director Scharff, Parks and Rec Superintendent Marshall, and City Clerk Nielsen.

#### **Modification of Agenda**

Mayor Poppa added Item B, the AARP Challenge Grant, to the Mayor's Report.

#### I. Public Comments

There were no public comments made.

#### IV. Mayor's Report

#### A. Women's History Month Proclamation

CMBR Raglow read the proclamation into the record and all Councilmembers agreed to sign on to it.

#### B. AARP

Mayor Poppa said he spoke with Arts Committee Co-Chairs Marek Gliniecki and Mary Schulteis about the highly competitive AARP Community Challenge Grant they are applying for. If awarded the grant, the funds would be applied to the Community Garden at the Community Center campus. They would like to install a new shed, picnic table, and some fencing. They would also like to add some artistic elements throughout the garden. Mayor Poppa asked for the Council's approval to submit the application.

CMBR Faidley suggested using the funds for the shed because a new one is sorely needed. She said it is a fully functioning community garden and that is the main motivator for the improvements.

CMBR Hill asked if there is a policy in place for staff to review grants before they are submitted as they do have the name of the City on them. City Manager Moody said he is happy to look at them before they are submitted. He noted that the committees do the legwork and that staff does add support as needed.

Mayor Poppa added that when there is a required match staff does review those applications. This AARP grant does not require a match.

Everyone expressed their support for the arts project.

#### V. Reports of City Liaisons and Committees

#### A. Diversity, Equity, and Inclusion Committee

Carrie Paulette and Harold Morales introduced themselves as the new co-chairs of the DEI committee. Ms. Paulette gave a committee update noting that they have been in a rebuilding phase over the past couple of months where they are defining their goals and narrowing their focus.

The first thing is to build better communication between the committee to the community and for the community to share with the committee. They have a goal to contribute monthly to the newsletter and want to share community events, issues, and ways for the community to get involved.

Mr. Morales recommended more Spanish translations noting they have that capability with the *Roeland Parker* but would like to see that be more visible on the site.

Ms. Paulette asked the Governing Body if they came across an issue or event for the committee to please send it to them.

Secondly, the committee wants to provide a DEI lens to the Council for City projects. They are working with Ms. Jones-Lacy on current relevant projects and the committee will provide their feedback.

The DEI committee meets the last Tuesday of the month. They are open meetings and actively recruiting new members.

Mr. Morales said to let them know what they can do to make the job of the Governing Body easier through a DEI lens.

CMBR Madigan said they need to have a joint meeting with the Historical Committee as they are working on projects they want to run by the DEI committee.

As Governing Body liaison to the committee CMBR Stocks said they are doing a good job.

#### B. Aquatics Center Advisory Committee

Mr. Marshall said they will be able to open the Aquatics Center seven days a week. Everyone was excited to hear that news. He said that lifeguard training will start soon, and they are also finalizing the season's activities so they can be advertised.

CMBR Hage is the liaison to the Aquatics Committee and said they have good energy. There is a lot of conversation about changes, but the focus is keeping the pool open seven days a week.

CMBR Faidley expressed concerns about alcohol consumption around pool and liability. Mr. Marshall said glass containers are always prohibited. He added that they have discussed liability and are in the process of taking care of that issue.

#### C. Community Garden

Judy Parker is the coordinator of the Seeds that Feed the Need Community Garden at the Roeland Park Community Center. She said they have 15 vegetable and herb beds and harvest through October. In total, they harvest about 900 pounds per year. The produce is donated to two food pantries, one at Roeland Park Methodist and the other at Mission Lutheran Church. The funds they receive pay for maintenance, purchase of seeds, upkeep, and repairs from vandalism. Ms. Parker also handed out sunflower seed packets to the Governing Body.

CMBR Faidley thanked Ms. Parker for caring for the garden for the past 12 years, noting that this will be her last year. She noted that Ms. Parker brings in family, friends, and scouts to help work the garden.

(Kansas City) – The Kansas City region is not only known for our beloved Chiefs. We are known as the home of SevenDays - Make a ripple, change the world.

Reat's mother and Dr. Corporon's daughter, Mindy Corporon, is co-founder.

A decade later, **SevenDays® 2024** continues the healing journey following the murders that took

the lives outside of Jewish facilities in April 2014. This year's events reflect the determination of **SevenDays**® to carry on kindness and change the world.

"Ten years ago, I didn't think I could survive ten days and frankly didn't want to. The pain of losing my loved ones, my people, shattered me into an emotional place where I found rebirth. I thought to myself, who am I now? Without my father and son, who can I be, and as importantly, what should I do," Corporon said.

"Determined to help our youth through the tragedy they were also living, our foundation focused then and now on educating around kindness. **SevenDays**® understands that accepting and understanding those around us and those whom we might not consider as a neighbor are those who need our kindness. Therefore, we promote kindness through education and dialogue throughout our communities, schools, and businesses," she said. "When one person understands the power of kindness and acts on it, they make a ripple. A ripple can change the world."

SevenDays® 2024 has some exciting anniversary things planned for its two public events.

Lisa Ginter, CEO of CommunityAmerica Credit Union, who was last year's Ripple of Kindness Honoree, will be on hand to present the award. ### **Recommendation:**

To approve an updated task order covering the design, bidding, and construction administration for the extension and improvement to Roe Parkway.

## **Details:**

The attached scope from Larkin covers the entire scope of professional engineering and construction related services for the extension of Roe Parkway to Roe Boulevard as well as the repair of existing Roe Parkway. The initial task order approved in 2021 just covered survey and design. The revised task order reflects survey, design, bidding, construction administration and inspections services. These fees amount to 11% of estimated construction costs (\$1.736 M). This is below the 15% we consider normal for these services. TIF 3 resources are sufficient to cover the cost of the design and construction (total project cost is estimated at \$1.95 M). The attached cost estimate reflects design recently reviewed by Council. The project scope has been expanded to provide a sidewalk extending from the new Roe Parkway intersection with Roe Boulevard south to connect to the sidewalk along the EPC site. This will create a complete sidewalk system along Roe Blvd, Roe Parkway and 48th Street.

The project is being paid from TIF 3 resources. These improvements are part of the TIF 3 Development Plan. TIF 3 resources are to be used by year end 2025.

These improvements are anticipated to occur in concert with redevelopment of the Rocks area. The west extension of Roe Parkway is planned to occur as a first phase of construction to provide a 2nd means of egress before construction along the existing (east/south) segment of Roe Parkway commences.


