The City Council encourages citizen participation in local governance processes. To that end, and in compliance with the Kansas Open meetings Act (KSA 45-215), you are invited to participate in this meeting. The following rules have been established to facilitate the transaction of business during the meeting. Please take a moment to review these rules before the meeting begins.

- A. **Audience Decorum.** Members of the audience shall not engage in disorderly or boisterous conduct, including but not limited to; the utterance of loud, obnoxious, threatening, or abusive language; clapping; cheering; whistling; stomping; or any other acts that disrupt, impede, or otherwise render the orderly conduct of the City Council meeting unfeasible. Any member(s) of the audience engaging in such conduct shall, at the discretion of the Mayor (Chair) or a majority of the Council Members, be declared out of order and shall be subject to reprimand and/or removal from that meeting. Please turn all cellular telephones and other noise-making devices off or to "silent mode" before the meeting begins.
- B. **Public Comment Request to Speak Form.** The request form's purpose is to have a record for the City Clerk. Members of the public may address the City Council during Public Comments and/or before

consideration of any agenda item; however, no person shall address the Council without first being recognized by the Mayor (Chair). Any person wishing to speak, whether during Public Comments or on an agenda item, shall first complete a Public Comment or Request to Speak form and submit this form to the City Clerk before the Mayor (Chair) calls for Public Comments or calls the particular agenda item

- 1. Public Comment on Non-Agenda Items. The Agenda shall provide for public comment about matters that are within the jurisdiction of the City but are not specifically listed on the Agenda. A member of the public who wishes to speak under Public Comments must fill out a Public Comment Request to Speak form and submit it to the City Clerk before the Mayor (Chair) calls for Public Comments.
- 2. **Public Comment on Agenda Items.** Public comment will be accepted on Agenda items. A member of the public, who wishes to speak on an Agenda item, including items on the Consent Agenda, must fill out a Request to Speak form and submit it to the City Clerk before the Mayor (Chair) calls the Agenda item.
- C. **Purpose.** The purpose of addressing the City Council is to communicate formally with the Council regarding matters that relate to Council business or citizen concerns within the subject matter jurisdiction of the City Council. Persons addressing the City Council on an agenda item shall confine their remarks to the matter under consideration by the Council.
- D. **Speaker Decorum.** Each person addressing the City Council, shall do so in an orderly, respectful, dignified manner and shall not engage in conduct or language that disturbs, or otherwise impedes the orderly conduct of the Council meeting. Any person, who so disrupts the meeting shall, at the discretion of the Mayor (Chair) or a majority of the Council Members present, be subject to removal from that meeting.
- E. **Time Limit.** In the interest of fairness to other persons wishing to speak and to other individuals or groups having business before the City Council, each speaker shall limit comments to five minutes. If a large number of people wish to speak, this time may be shortened by the Mayor (Chair) so that the number of persons wishing to speak may be accommodated within the time available.
- F. **Speak Only Once.** Second opportunities for the public to speak on the same issue will not be permitted unless mandated by state or local law. No speaker will be allowed to yield part or all of his/her time to another, and no speaker will be credited with time requested but not used by

another.

- G. Addressing the Council. Comment and testimony are to be directed to the Mayor (Chair). Dialogue between and inquiries from citizens at the lectern and individual Council Members, members of staff, or the seated audience is not permitted. Council Members seeking to clarify testimony or gain additional information should direct their questions through the Mayor (Chair). Always speak from the microphone to ensure that all remarks are accurately and properly recorded. Only one speaker should be at the microphone at a time. Speakers are requested to state their full name, address and group affiliation, if any, before delivering any remarks.

Pledge of Allegiance

Mayor Kelly called the City Council meeting to order and led everyone in the Pledge of Allegiance.

Roll Call

City Clerk Nielsen called the roll. CMBRS Raglow and Rebne were absent. Staff members present were City Administrator Moody, City Attorney Moeller, Public Works Director Scharff, Police Chief Morris, Parks and Recreation Superintendent Marshall, and City Clerk Nielsen.

Modification of Agenda

There were no modifications to the agenda.

I. Citizen Comments

Gretchen & Ardie Davis (5206 W. 58th) Mr. Davis stated he and his wife are advocates for their right to vote, but will support appointment by the Council for an interim mayor to hold the position under the next election.

Susan Sanders - Mayor Kelly read Ms. Sanders' comments into the record stating a support for an individual's right to vote. However, she understands the expense of a special election is too great and trusts the Governing Body to appoint an interim mayor.

Judy Hyde - City Clerk Nielsen read Ms. Hyde's comments into the record of being a strong advocate of the right to vote. In this potential case, she would support an interim mayoral appointment so the City will not go without representation. An appointment by the Governing Body will ensure that all wards are represented.

Jill Clemens - Ms. Clemens' comments were read into the record by Mayor Kelly. She expressed concern of the City being without a mayor if one were no appointed. She would prefer a special

election but understands that is not possible at this time and would support a Governing Body interim mayor appointment.

III. Business from the Floor - Proclamations/Applications/Presentation

There was no Business from the Floor.

IV. Mayor's Report

A. Indigenous People's Day Proclamation

Mayor Kelly said this is the first time in Roeland Park that Indigenous People's Day has been formally recognized by the City and reviewed the proclamation.

MOTION: CMBR DICKENS MOVED AND CMBR FAIDLEY SECONDED TO APPROVE THE PROCLAMATION OF INDIGENOUS PEOPLE'S DAY FOR OCTOBER 10, 2022, IN THE CITY OF ROELAND PARK. (THE MOTION CARRIED 6-0.)

V. Reports of City Liaisons and Committees A. MARC - Bike & Pedestrian

Mayor Kelly thanked CMBR Faidley for her service on the MARC Bicycle and Pedestrian Committee. Her report is in the agenda packet. There is also a link to the Complete Streets Assessment by MARC and also details about how streets in Roeland Park are rated. It was also noted that MARC received the RAISE (Rebuilding American Infrastructure with Sustainability and Equity) grant after a very competitive process, something they feel lucky to have received.

B. Arts Advisory Committee

CMBR Poppa reported that the Parade of Hearts heart has been installed at the northwest corner of 48th and Roe Boulevard. He said the mural was defaced but has been cleaned and repaired. The bird from the Jorge Blanco bench has gone missing and the artist will be replacing it. Also, there is a call for art for the City's Gateway project and that has been posted in various places seen by artists.

CMBR Madigan asked what steps they can take to keep the bird from disappearing. CMBR Poppa said some suggestions would be to install a security system in the area, but that would not prevent a theft. They could also consider moving the bench if it continues to happen. CMBR Madigan asked if Mr. Blanco would be agreeable to not having the bird. CMBR Poppa said they would like to get the bench back to its former glory and see if the problem persists.

Mayor Kelly thanked the Arts Committee for their contributions to the City. He also stated he appreciates Mr. Blanco for his work, dedication, and partnership with Roeland Park. Mayor Kelly added that he hopes to have the bench art piece as intended for their community.

C. Parks Committee

Sarah Martin from the Parks Committee said they are finishing Phase 3 of R Park. They are planning for a celebration in November if Phase 3 is complete. She said the traffic garden has been getting a lot of use. They will also be installing a fireplace screen and she thanked Mr. Marshall for figuring that out noting that he is a great person to work with. The committee has settled on a color palette for the bike sculpture in the park.

The Cooper Creek Park sign has been installed and Daniel is building natural play structures for the park.

The committee is turning their focus onto Nall Park improvements and are dedicated to making it a shining star.

Ms. Martin will speak further about the wildflower garden planned for R Park at the Workshop following the Council meeting.

There was no Unfinished Business discussed.

VII. New Business

A. Approve Agreement with the Chamber for ARPA-Related Services

CMBR Poppa said he was excited about the opportunity to partner with the Northeast Chamber to build a business community in Roeland Park.

Mayor Kelly thanked staff for their work on these unique partnerships.

MOTION: CMBR MADIGAN MOVED AND CMBR POPPA SECONDED TO APPROVE THE SERVICE AGREEMENT WITH THE NORTHEAST JOHNSON COUNTY CHAMBER OF COMMERCE FOR ARPA-RELATED SERVICES. (THE MOTION CARRIED 6-0.)

B. Approve Agreement with Habitat for Humanity for ARPA-Related Services

MOTION: CMBR FAIDLEY MOVED AND CMBR POPPA SECONDED TO APPROVE THE SERVICE AGREEMENT WITH HABITAT FOR HUMANITY KANSAS CITY FOR ARPA-RELATED SERVICES. (THE MOTION CARRIED 6-0.)

C. Committee Reappointments

MOTION: CMBR MADIGAN MOVED AND CMBR BRAUER SECONDED TO APPROVE THE COMMITTEE REAPPOINTMENTS OF: LYNDA LEONARD, MAREK GLINIECKI, MARY SCHULTEIS, AND JONNA CROSBY TO THE ARTS COMMITTEE; LAURA SAVIDGE, JAMIE DAVIS, LINDA THORNBURGH, SARAH MARTIN, KAILEE NOLAND, AND LINDA HEINEN TO THE PARKS COMMITTEE; DAVID SMITH AND MELISSA CASTILLO TO THE SUSTAINABILITY COMMITTEE; AND CHRIS BURT TO THE AQUATICS COMMITTEE. (THE MOTION CARRIED 6-0.)

Mayor Kelly reminded everyone if they would like to continue serving on their committee to make their intentions known to City Clerk Nielsen by the last Governing Body meeting in December.

CMBR Faidley thanked those interested in serving on a committee for filling out an application. She said they appreciate it, and it does help with their selection process.

VIII. Ordinances and Resolutions

A. Charter Ordinance 38 - Filling Vacant Governing Body Seats

Mayor Kelly expressed his appreciation to the staff and Council for working through this process.

CMBR Madigan asked if this would go through the racial and equity impacts that they have discussed. Mayor Kelly responded that that is part of a budget item in and is a process being worked on; however there is nothing specific as of yet and no specified timeline as to such.

City Administrator Moody said they will coordinate that with Ms. Winn's return after her leave of absence.

CMBR Faidley said she is not ecstatic of the Johnson County election process, but she supports their staff in this challenging time and would like for them to be a help in that process.

CMBR Poppa said it does put residents at a disadvantage in that they are not equitably represented for a period of time to avoid overlapping elections. The appointment process they have worked on feels adapted to fit their community and ensures residents are equitably represented by an interim mayor and then everyone has the opportunity to vote at the next election.

CMBR Hill said the special election is important and that the residents want to vote. She said they will most likely not have a full Governing Body for longer than they would have to wait for that special election. She does feel they should go forward with the appointment process, but wants the residents to know that if she feels this process is being used to benefit a candidate for a reelection, then she will call the item back to table as this has to be an honest and truthful process.

As this is a charter ordinance, a roll call vote was taken with the Mayor also casting a vote.

MOTION: CMBR DICKENS MOVED AND CMBR FAIDLEY SECONDED TO APPROVE CHARTER ORDINANCE NO. 38 - FILLING VACANT GOVERNING BODY SEATS. (THE MOTION CARRIED 6-1 WITH CMBR MADIGAN VOTING NO.)

B. Ordinance 1035 - Prohibiting Parking on Elledge

Mayor Kelly thanked everyone for their work on this and also the school for their input.

MOTION: CMBR HILL MOVED AND CMBR MADIGAN SECONDED TO APPROVE ORDINANCE NO. 1035 - PROHIBITING PARKING ON ELLEDGE. THE MOTION CARRIED 6-0.)

CMBR Faidley asked about the cyclists going to school and if there has been any feedback from parents, educators, or neighbors. City Administrator Moody said he has met with the school district and Police Department, but could also get feedback from the crossing guards. He would like to give it until the end of the school year to see if there are any improvements or changes that should be made before the start of the next school year.

CMBR Hill asked if car riders, walkers, and cyclists are all dismissed at the same time. CMBR Faidley said she believe it is by grade.

CMBR Madigan asked the City Attorney what their preference would be for the signs. Ms. Moeller said they preferred Option 3.

Mayor Kelly said it is a necessity to continue follow-up on the process as it is so important.

MOTION: CMBR HILL MOVED AND CMBR FAIDLEY SECONDED TO APPROVE SIGN OPTION NO. 3. (THE MOTION CARRIED 6-0.)

IX. Reports of City Officials

A. Review 3rd Quarter Objectives Progress Report

City Administrator Moody said they have completed five of eleven objectives adopted for 2022. Some were not completed within their timeline and those reasons are outlined in the report. Some progress has been made on historical signs and they are looking into Freedom's Frontier National Heritage Area as a local historian.

The traffic garden and Phase 3 objectives for R Park will be completed soon. The marquee sign objective for Roe has been withdrawn. And the Neighborhood Services electric vehicle objective was completed in August.

CMBR Faidley asked if Freedom's Frontier works with tribal leadership. City Administrator Moody agrees this is a studious step and will ask the Freedom's Frontier director to provide contact information for groups they view as active in our region to attempt to get feedback. CMBR Faidley said she felt their group focused on white settlement and she does not want to get too far along with them if they do not meet the needs of what they are looking for in covering all the stories.

B. Review 3rd Quarter Strategic Plan Progress Report

City Administrator Moody said the report highlights the initiatives that have seen progress. He notes the strategic plan is a significant document since they began five years ago and reflects a \$27 million investment with 162 initiatives.

C. Review 3rd Quarter Public Safety Report

Police Chief Morris said they have been extremely busy with a lot of calls. He reviewed the UCR statistics from his report. He noted that there has a been a higher number of arrests and they are seeing more amphetamine.

At this time he did not have a report from the co-responder or animal control. Also, officers will be working security at the Bishop Miege homecoming game this weekend.

CMBR Madigan asked if they met their requirement for a permit. Police Chief Morris said they have met all the requirements and the person doing fireworks will pay the \$100 fee.

CMBR Faidley asked about the crime classification categories of mental disorder and mental disorder, not applicable. Police Chief Morris said for every call that has a report, if mental disorder is checked, then it immediately goes to the co-responder for follow-up care.

CMBR Faidley also asked about the high numbers for Officer Budde. Police Chief Morris said he is a traffic patrol uniformed officer on a motorcycle which accounts for his higher traffic numbers.

CMBR Poppa noticed the bump in activity midweek and asked if that was a trend or if there was a reason. Police Chief Morris said you always think of Friday and Saturday as being days for a higher spike, and could not explain the midweek stats.

Police Chief Morris said on Saturday, October 8th from 3-7 p.m. at the Community Center will be their Community Safety Day. Rango, the City's K-9 will be there as well as food, a bounce house, and public safety equipment on display.

D. Review 3rd Quarter Public Works Report

Public Works Director Scharff reviewed staff hours and how they were divided up over the third quarter, the majority of which being spent on parks and green space maintenance. He also provided project updates for Elledge Drive with a wrap-up anticipated by October 21st. He also reviewed the progress on the Buena Vista project and that it should be complete mid-October. Mr. Scharff showed before and after pictures of the completed Johnson Drive project.

Public Works Director Scharff also included the leaf collection map in his report, stating that collection will start October 31st. He also reviewed the street sweeping schedule to date.

Also covered in Public Works Director Scharff's report was the 2022 UBAS and surface treatments, Phase 2 of the streetlight maintenance, and the Phase 3 improvements at R Park.

CMBR Madigan asked if they ever start leaf collection on the east side of town rather than the west. Public Works Director Scharff said that has never been done while he's been with the City. The program starts in the upper northwest portion of the City. The map has been posted and there is an interactive map to track the truck.

Staff recommends awarding the bid to Aquila Industries for Phase 1 of the Community Center renovations including add alternate items 1A, 1B, 2A, 2B, 3A, 3B, 4, 5, 6, and 7.

Details:

Two bids were received for Phase 1 of the Community Center renovations on 10/6/22. Attached is a summary of the base bids as well as the amount for each add alternate. Aquila Industires provided the low base bid as well as the low bid when including all of the add alternates (total of \$1,602,235). Alternate 7 is for the staining of City Hall (at just under \$40,000) which \$24k of that amount will be paid for out of TIF 2 (this will zero out the TIF 2 fund). The total for the Community Center elements is \$1,562,497.

\$1.5 million is budgeted in the Special Infrastructure fund plus another \$385k budgeted in the ARPA fund for this project, however \$200k in CDBG grant funds were anticipated in support and the City was not awarded any CDBG funding for this project. Net funds budgeted and available for the project therefore totals \$1,709,00 or \$106k more in funding than the base bid plus all add alternates. This will more than cover construction administration services provided by SFS.

SFS has checked references for Aquila Industries as well as confirmed they have experience on similar projects. Attached is a letter from SFS.

Dear Keith,

As requested at the bid opening for the above referenced Project, SFS Architecture contacted Aquila Industries, representing the lowest bid to submit a Qualification Statement, a Schedule of Values, and a list of main subcontractors (see attached). A list of professional references and projects are included in the Qualification Statement. The qualifications attached also include work experience, project types and size (in terms of construction dollars). Aquila Industries demonstrated previous execution of projects similar in scope and size (in terms of construction dollars) during the past five (5) years.

Aquila Industries' professional references for recent projects were complimentary of the level of service they received. SFS Architecture spoke with three references for projects of varying size and scope. The school's Building and Grounds Supervisor for Hickman Mills School District mentioned responsiveness, diligence, and would recommend Aquila Industries for future work. SFS Architecture also spoke with Joel Smith, Chief Operations Officer at Universal Construction Company. He would recommend the contractor for their compliance with plans and specifications, responsiveness and following the construction schedule. He mentioned tracking could be better. Lastly, Matthew Moppin, Facilities Operations NW Region for Missouri Department of Transportation (MODOT) said this will be his first experience working with Aquila Industries. He mentioned the preconstruction meeting last week went well and they were responsive. Two of three references would recommend working with Aquila Industries in the future. The last reference, Matthew Moppin did not want to recommend the contractor at this time because this will be his first time working with the contractor.

Based on our inquiries, SFS Architecture did not find any reason for the City of Roeland Park to withhold consideration of Aquila Industries as the apparent low bidder.

Details:

Westwood Hills has approached Roeland Park requesting leaf pickup service. Staff discussed with Westwood Hills the date and time for the leaf pickup service. Staff determined that Roeland Park could provide the leaf pickup service for Westwood Hills on Sunday, December 4th, 2022. This date was determined as Roeland Park will pick up leaves for our residents Monday-Saturday and the leaf pickup service for Westwood Hills would have to be done on a Sunday

Roeland Park will provide (1) operator and (1) leaf vacuum truck as stated in the agreement. Staff will dispose of leaves at the Missouri Organics site as they have agreed to take the leaves for that pickup date. Westwood Hills will be responsible for all invoices and Missouri Organics will invoice Westwood Hills directly for leaf disposal.

Roeland Park will charge Westwood Hills the following hourly rates:

(1) Operator - \$55 (1) Leaf Vac Truck - \$95 Fuel - \$5.75

Staff would begin the leaf pickup service starting at 7a.m and continue until all leaves have been picked up. Staff believe this effort could take up to 8 hours to complete. Per the agreement, if for any reason Roeland Park cannot dispose of leaves at Missouri Organics, staff would haul leaves to the public work building. Also stated in the agreement, Westwood Hills will be invoiced for any charges related to dumpster rentals/hauling fees, hourly use of PW equipment, as well as hourly

rates for the operator for disposal of any leaves picked up for Westwood Hills

2022 CONTRACT FOR LEAF PICKUP BETWEEN THE CITY OF ROELAND PARK, KS, AND THE CITY OF WESTWOOD HILLS, KS

THIS IS A CONTRACT (the "Agreement") by and between the CITY OF ROELAND PARK, a legal municipality of the State of Kansas, herein referred to as "ROELAND PARK" and the CITY OF WESTWOOD HILLS, a legal municipality of the State of Kansas, herein referred to as "WESTWOOD HILLS".

WITNESSETH:

WHEREAS, it is the desire and intent of WESTWOOD HILLS to contract leaf pickup to ROELAND PARK and to compensate ROELAND PARK pursuant to the terms of this Agreement.

WHEREAS, this Agreement constitutes a contract between municipalities pursuant to K.S.A. 12-2908 to perform a governmental service, activity, or undertaking which each party hereto is authorized by law to perform and accordingly shall not be regarded as an interlocal agreement under the provisions of K.S.A. 12-2901, et seq., and amendments thereto.

NOW, THEREFORE, it is hereby agreed as follows:

1. SERVICES.

ROELAND PARK agrees to pick up the leaves placed in the designated locations in WESTWOOD HILLS beginning on Sunday, December 4, 2022, so long as those leaves are not in the streets, roads, boulevards, or parkways but rather are located in a "Qualifying Area." For purposes of this Agreement, "Qualifying Area" shall be defined as the area within eight (8) feet back from the curb of all streets, roads, boulevards, and parkways within WESTWOOD HILLS. Such leaf pick-up is referred to herein as "Leaf Service."

WESTWOOD HILLS agrees that any leaves to be picked up by ROELAND PARK shall be on a Qualifying Area in WESTWOOD HILLS prior to 7:00 am central standard time on Sunday, December 4th, 2022. Should ROELAND PARK be unable to perform on this date, it will notify WESTWOOD HILLS no later than the close of business on Thursday, December 1, 2022, and arrange an alternative date that is mutually satisfactory to the parties.

ROELAND PARK agrees to pick up leaves in the Qualifying Area for one (1) eight-hour day or until the Leaf Service is completed, whichever occurs first.

WESTWOOD HILLS agrees to compensate ROELAND PARK for the completed work in accordance with the pay schedule set forth in the "PAYMENTS" section of this Agreement.

ROELAND PARK agrees to pick up the leaves in the manner stated above and to deposit those leaves at the Missouri Organics disposal site located at 1260 Alma St., Kansas City, Kansas 66103, after which ROELAND PARK has no further obligation with respect to the handling or disposal of such leaves. WESTWOOD HILLS is solely responsible for paying its own costs for disposal of the leaves at Missouri Organics, and WESTWOOD HILLS will be billed directly from Missouri Organics.

WESTWOOD HILLS reserves the right, for any reason it sees fit, to decide, in its sole discretion, that ROELAND PARK shall dispose of the leaves in ROELAND PARK. If such a decision is made by WESTWOOD HILLS, then WESTWOOD HILLS agrees to compensate ROELAND PARK an additional fee defined in the "PAYMENTS" section for the disposal of the leaves. Such a fee will also be incurred by WESTWOOD HILLS upon reasonable notice by ROELAND PARK that it cannot deposit the leaves at Missouri Organics.

2. POTENTIAL ALTERATION OF SCHEDULE

ROELAND PARK and WESTWOOD HILLS agree that any mechanical or weather issue that delays ROELAND PARK from completing the leaf pickup in ROELAND PARK, and thus delays the start of leaf pickup in WESTWOOD HILLS, shall not alter any terms of this Agreement except the dates and times at which leaf pickup is completed, provided however that WESTWOOD HILLS shall be permitted to terminate this Agreement for any such delays of 15 days or longer. If this Agreement is so terminated by WESTWOOD HILLS, WESTWOOD HILLS shall be entitled to reimbursement for any prepaid services which were not rendered. ROELAND PARK will make every good faith effort to complete the leaf pickup as scheduled above.

3. PAYMENTS.

As consideration for provision of Leaf Service to WESTWOOD HILLS, WESTWOOD HILLS agrees to pay ROELAND PARK for each and every single one (1) hour of work completed as part of the Leaf Service as follows:

- One operator at \$55.00 per hour
- One leaf vacuum truck at \$95.00 per hour
- Fuel at \$5.75 per hour

If, as provided in Section 1 of this Agreement, the leaves collected by ROELAND PARK are not deposited at the Missouri Organics Site, then WESTWOOD HILLS will compensate ROELAND PARK for its actual expenditures incurred in disposing of such leaves, including but not limited to: fuel costs at the rate of \$5.75 per hour, a minimum of one (1) laborer at the rate of \$55.00 per hour, a minimum of one (1) loader at the rate of \$95.00 per hour, and all costs incurred by renting a dumpster or multiple dumpsters.

4. FULL COOPERATION.

Both parties agree to cooperate fully with all reasonable requests for information that are necessary for the completion of the tasks herein.

5. <u>RELATIONSHIP OF THE PARTIES</u>.

The method, means, manner, personnel, and equipment by which services are provided under this Agreement shall remain in the exclusive control of ROELAND PARK. This Agreement is not intended to and will not constitute, create, give rise to, or otherwise recognize a separate legal entity, whether such entity may be an administrative entity, joint venture, partnership, or formal business association or organization of any kind between the parties.

In providing services under this Agreement, ROELAND PARK, its officers, agents, employees, representatives, or independent contractors shall remain subject to the exclusive supervision and control of ROELAND PARK. Accordingly, ROELAND PARK retains the exclusive right to direct the work of its employees performing work under the terms of this Agreement. The manner and method by which services are provided under this Agreement shall remain in the exclusive control of ROELAND PARK. Nothing in this Agreement shall be construed as creating an employment relationship between WESTWOOD HILLS and any officers and/or employees of ROELAND PARK providing services pursuant to the terms of this Agreement.

6. INDEMNITY.

To the extent allowed by law and subject to the immunity and maximum liability provisions of the Kansas Tort Claims Act, ROELAND PARK agrees to indemnify WESTWOOD HILLS and to hold WESTWOOD HILLS harmless for any liability incurred in connection with the performance of ROELAND PARK's duties and obligations under this Agreement to the extent liability is attributable to the fault or negligence of ROELAND PARK. To the extent allowed by law and subject to the immunity and maximum liability provisions of the Kansas Tort Claims Act, WESTWOOD HILLS agrees to indemnify ROELAND PARK and to hold ROELAND PARK harmless for any liability incurred in connection with the performance of WESTWOOD HILLS' duties and obligations under this Agreement to the extent liability is attributable to the fault or negligence of WESTWOOD HILLS.

7. MODIFICATIONS.

No changes or additions to this Agreement shall be valid or binding upon either party unless such changes or additions are made in writing and executed by both parties

8 LEGAL FEES AND COSTS.

If any suit or action is filed by any party to enforce or interpret a provision of this Agreement, or otherwise with respect to the subject matter of this Agreement, the prevailing party shall be entitled, in addition to other rights and remedies it might have, to reimbursement for its expenses incurred with respect to such suit or action, at trial and on appeal, including court costs and reasonable attorney's fees.

9. ENTIRE AGREEMENT.

This Agreement is the entire agreement between the parties and supersedes all previous agreements or understandings, both written and unwritten, between them. This Agreement may be modified only in writing, provided both parties have signed the amended document. This Agreement is not intended to affect or otherwise change any other agreement between the two cities.

10. GOVERNING LAW.

This Agreement shall be governed by and construed under the laws of the State of Kansas. The sole and exclusive venue for any action premised upon the rights and obligations within this Agreement shall be within the District Court of Johnson County, Kansas.

11. COPIES OF CONTRACT.

Copies of this Agreement shall be filed with the City Clerk of ROELAND PARK and with the City Clerk of WESTWOOD HILLS.

12. EFFECTIVE DATE.

This Agreement shall take effect immediately after it has been executed and copies filed as set forth in the preceding paragraph.
